President's Corner

The goals of the White Lake Citizens League are to improve the water quality of the lake and, just as importantly, to improve the quality of lake living for all of the residents of White Lake. With your support and involvement, and a record membership last year of almost 50% of the lake residents, these goals were easily achieved. We are fortunate to have a very dedicated Board of Directors, and groups of volunteers who work hard to make all of our activities and events happen.

Last year, we added a Fishing Tournament and Coast Guard Auxiliary safety inspections to go along with the annual Pancake Breakfast, Home Tour, Boat Parade, Fireworks, and the weekly spectacle of Sailboat Races. We see all of these activities and events continuing in 2013.

We also proposed funding for a dredging project, promised nearly thirty years ago, to be completed over the next five years. The White Lake Improvement Board voted to include this funding in the Special Assessment District. We rejoined the Michigan Cooperative Lakes Monitoring

Program (CLMP) to measure water quality for our own and the state's use, and we continue to attend the Michigan Lake and Stream Association's annual conference to keep abreast of such things as state programs, water quality issues, riparian rights, and marine law. We continue to be actively involved in managing the weed control and Sheriff Marine Patrol programs with the White Lake Improvement Board.

This year we are hoping to institute Coast Guard Auxiliary boating safety classes, and a Welcoming Committee for new lake residents. All of these activities take considerable effort to accomplish, and we can use not only your financial support but also your personal involvement. Please attend one of our monthly meetings to learn how you can help. We are considerate in distributing efforts among many volunteers, and those who participate find it both enjoyable and rewarding.

Happy Spring everybody! Of course, with the budding of the trees, the return of the birds, and the renewal of our boat registrations, comes our annual membership drive. In 2012, thanks to the generosity and commitment of our membership, and the hard work of our Block Captains, we had a record paid membership of 291 homeowners and 36 area businesses. This translated directly into what is arguably the finest private fireworks display in the county. In order to keep up the momentum, we are setting a goal for this season of 310 members (a 3% increase). We're hoping you will support this goal with both your membership and donations, as well as in encouraging your friends and neighbors to join. We all enjoy the fireworks program, and many of us plan gatherings of family and friends around this day.

For many years, we have had Block Captains canvassing the neighborhoods to receive dues and donations. Please welcome your Block Captain when they call - they are all volunteers, and are a great help with the membership drive. We always need more block captains, especially along Duck Lake Road, in the canal area off Jackson Boulevard, and in several other areas. Dredging Project

Last summer, the WLCL hired an engineering consulting firm to study and develop a plan for dredging the channels leading from the northwest bay to the 7 Harbors canal. The resulting engineering study determined the scope and cost of a project, to be completed within five years.

At a public hearing on September 24, 2012, the WLCL Board of Directors recommended that the rates for the Special Assessment District be increased to provide funding for the dredging project during the 5 year period from 2013-2017. After listening to comments from residents, the White Lake Improvement Board (WLIB) unanimously approved the project. The entire WLCL presentation can be viewed by clicking on the link on the "Special Assessment District (SAD)" page of our website.

The nature of the assessment will allow funds to build in the Special Assessment District to cover the cost of each phase of the project during the 5 year period. The phases include the actual dredging, temporary storage and dewatering of the spoils, and permanent disposal of the material (at a site with contaminant levels similar to those in the dredged spoils).

There is still a great deal that needs to be done to insure the successful completion of this project. This includes locating suitable temporary and permanent disposal sites, preparing a bid document, and letting the contract. Anyone who has experience in these areas, and who would like to assist, please contact **president@wlcl.org**. With some help, there are opportunities to reduce the overall cost of the project below the current estimates and expedite the completion of the project.

"Taps" will be played, and we will sing our national anthem while we raise the flag to full mast. ANNUAL MEETING

Marine Sheriff Patrols

Last summer, the Oakland County Sheriff Marine Unit patrolled White Lake for 205 hours on weekend, holiday, and random midweek days. During these patrols, the Sheriff made 838 contacts, conducted 155 safety inspections, and issued 13 tickets and 170 warnings. Detailed statistics provided by the Sheriff's office are available on our website.

These statistics, along with the lack of any serious incidents, and generally favorable informal feedback, convince us that these patrols were helpful in making White Lake a safer place for many activities. The patrols cost just under \$6,500 in 2012

(about \$11 per household, funded from the SAD), and similar funding is budgeted to continue the patrols in 2013. We continue to formally encourage Oakland County to restore county funding for these patrols.

Residents are reminded to report serious incidents or dangerous activity immediately by calling 9-1-1. Weed Control

All in all it was a good winter. Those of us who don't flee south during the winter have figured out ways to entertain ourselves during the cold months - which seemed excessively long this year! On White Lake, there's ice fishing, cross-country skiing, snowmobile riding, motorcycle races, and the White Lake Inn sponsored a number of events throughout the winter, including TWO ice golfing tournaments this year.

But now comes, for most of us, the reason we live on White Lake - the warm summer season. Along with that warmth comes the growing season, which includes lake weeds. We have had an organized way to deal with those weeds for the past 25 years or so, and this year will be no different. This year we are planning a conventional treatment program, much like what we executed last year with overall success. Success, we believe, is measured by our ability to keep the lanes of navigation clear, as well as other areas of nuisance weed growth in swimming areas and near docks and beaches. We also should mechanically remove weeds near our shorelines by raking where we can. As residents, we must realize that we don't want the lake to look like a swimming pool. We can't eradicate all of the weeds on the lake, and we don't want to.

The weeds in areas near the islands and coves where people generally don't navigate should be left alone for fish habitat, and that has been our philosophy all along.

We do several lake surveys during the summer to identify weed growth problem areas, and you may see us treating some areas of the lake - but not others - based on the results of these surveys. We also depend heavily on lake resident's calls to the **Hotline (248-887-5658)** to alert us about weed problems we haven't identified. So if there are excessive weeds in your area, please call in and we will respond.

Also remember the 5 items that help keep our lake clean:

1. Use fertilizer sparingly, and use only low-phosphorous types.
2. Have your septic tank pumped every 2 years.
3. If you have tree branches hanging over the water's edge, trim them off.
4. If possible create a buffer zone of natural plant growth 6 to 8 feet at the shoreline, and don't apply fertilizer in this area.
5. If you are able, keep your shoreline clean by raking the material off the bottom.

Water Quality Testing

The White Lake Citizens League participates in the Cooperative Lakes Monitoring Program (CLMP) sponsored by the Michigan Clean Water Corps. The Michigan Clean Water Corps (MiCorps) is a network of volunteer monitoring programs in Michigan. It assists the Department of Environmental Quality (DEQ) in collecting and sharing water quality data for use in water resources management and protection programs in the state.

It is important to measure our water clarity and certain chemical markers to ensure that we can monitor changes that naturally occur during the season and from year to year. Results of our testing, and a comparison to other lakes in our county and statewide, are available on the CLMP website, which is linked from

the "Water Quality & Weed Control" page of our website.

During 2012 we focused on 2 water clarity test procedures - Secchi Disk and Total Phosphorus. The Secchi Disc is a relatively simple test that is performed every 2 weeks to measure visual clarity at the deepest part of the lake. The White Lake data showed a range of 14-20 feet. These values are "normal" for the size and depth of our lake in comparison to other lakes in Oakland County. Rapid changes in this data from year to year would be an important warning signal.

Total Phosphorus measurement is a controlled test involving the collecting and sending of several bottled samples of lake water to the designated CLMP labs for testing. This test is conducted

once in spring (called overturn) and once in late-summer. Phosphorus is the most important nutrient impacting algae growth.

In 2013, we will add the "Exotic Aquatic Plant Watch" to our testing. Plant life is an essential element for any healthy lake. However it is important that we monitor our current plant life and watch for the plants that do not naturally belong in our Michigan lakes. We will map out the lake and sample plant life from key areas of potential concern, where non-native plants can be introduced via pollution/contamination. We would welcome any voluntary assistance from residents on this task. Please contact **Roy Eastham (rleastham@comcast.net)** if you are interested in helping.

Lake Level Management

You probably know that we are extremely fortunate to have a "Lake Augmentation Pump" to keep the water level of White Lake fairly consistent during the summertime. Located in the North Canal, the pump draws water from a deep well to raise the level of the lake when necessary. If you have friends who live on lakes without a way to manage the level, they probably experienced significantly low levels during the hot, dry summer last year. With the current environmental regulations and political climate, it is almost impossible to install new augmentation pump systems in lakes which do

not already have them.

The cost of operation of this pump (electricity, maintenance, and monitoring) is billed to lake residents in the "WHITE LAKE LEVEL" assessment on your Winter Tax Bill. (Note that this is a different assessment than the "WHITE LK IMPRV" assessment, which is the Special Assessment District that finances weed control, water quality testing, Marine Sheriff patrols, and dredging.) Lake Level Management (cont.)

Unfortunately, there were mechanical problems with the pump late last summer, and you probably noticed that the lake level fell at the end of the season (although we like to have it lower during the wintertime anyway). The pump motor was removed and repaired over the winter, and the pump impellers were pulled up from the well and cleaned. We have been assured by the Oakland County Water Resources Commissioner, who is responsible for the well, that everything will be working in time for this year's season. The cost of these repairs is projected to be about \$75,000,

and this will be added to the normal 2013 operating costs of the well in your Winter 2013 tax bill. The assessment rate varies by the type and location of your property, but it is projected that this will add less than \$10 to the bill of off-lake properties, and less than \$140 to most lakefront properties. None of us like extra charges on our tax bill, but this augmentation pump system is one of the more valuable assets of our lake, and we feel lucky that these repairs were able to be completed in a cost effective manner before the summer boating season.

New Residents

We have developed a Welcome Package designed to help new residents of our White Lake community. It contains information about the lake and the community, including offers from local businesses. There is information about boating safety and regulations, and about enjoying and navigating around our lake.

If you become aware of a newly arrived family in your area, please contact **Bill Maine (membership@wlcl.org)** or **Bob Parrett (communication@wlcl.org)** with their address (and their name, if possible). Please don't assume that someone else has already contacted us! Ideally, we would like to get a Welcome Package into the hands of each new resident within a week of them moving into their new home.

Sailing

Once again, sailing season is rapidly approaching (or so the calendar says), and soon the racing fleet will be preparing their boats. Though winter was long this year, there are signs that soon we will see glassy water and cat's paws (ripples) showing the racers the fastest way to the finish line. From the beginning to the well-seasoned sailor, all have enjoyed "just being out there" and sharing the experience with others.

Fishing

The 2nd Annual WLCL Fishing

Hunting Regulations

It appears that occurrences of illegal hunting on White Lake have been reduced since we began publicizing the regulations regarding hunting on the lake. As a reminder, there is no hunting allowed anywhere on the portion of the lake within White Lake Township, and no hunting allowed within 450 feet (150 yards) of any property on the portion of the lake within Highland Township.

The WLCL is working with Highland Township officials to encourage them to amend their ordinance to match White Lake Township's ordinance.

Vessel Safety Inspections/Boaters Safety Course

Last year we hosted a very successful Vessel Safety Inspection Campaign for WLCL members, thanks to our friends at the U.S. Coast Guard Auxiliary. Upon the successful completion of the safety inspection, members received a Coast Guard Inspection Sticker for their watercraft. We plan to offer these inspections again this year.

Michigan Public Act 62 of 2012 became effective on November 1, 2012: "If a watercraft bears a safety check decal from the U.S. Coast Guard, a peace officer may only stop the vessel if there is suspicion that the boat or operator is in violation of marine law or engaged in criminal activity." This law minimizes so-called "bikini stops" of vessels displaying a current Inspection Sticker.

New this year - the WLCL and the U.S. Coast Guard will be offering the Official Boater Safety Education Course for WLCL members 12 years and older. This certification is required for most PWC operators, and for ALL boat operators aged 12-15. It is recommended for anyone operating a watercraft in Michigan! The cost is \$20.00 and will consist of 2 evening classes at 4 hours each.
